WORK SESSION MINUTES
OCTOBER 7, 2024**

The Old Town Historic Commission held their meeting at City Hall located at 5490 5th Street Cottleville, Missouri.

There were four (4) members present and three (3) absent.

A. Draft amendments to Article VIII Section 400.175 Old Town Historic District Commission and Article III Section 405.095 Special District/Old Town Cottleville.

Mike Padella, City Administrator provided the Commission a draft ordinance to review and obtain feedback on some proposed code changes which would clean up the process and definitions of various items within the above articles including Certificate of Appropriateness's, when to use consultants, fee schedules, an historic preservation process, demolition requests, appeals, uses and more. It was noted that this Commission historically has mostly reviewed *permanent* signs and *exterior* building elevations or renovations but not uses. It was the consensus of the Commission to continue reviewing permanent signage and building exteriors only but not uses which are reviewed by Planning and Zoning and the Board of Aldermen. It was further noted this ordinance is still a work in progress and is a draft only. It also noted a public hearing will be held with Planning and Zoning and then with the Board of Aldermen regarding a final draft of these code changes, later this year most likely.

Lastly, Mr. Padella requested the Commission continue to review the draft as time permits. He further said the Missouri Historic Preservation Office is reviewing the draft as well.

Staff, Board and Commission Updates

During this time, Mr. Padella stated he has received a complaint regarding electric or lighted window signs such as "beer" or "open" signs within the Old Town Historic District. He further provided several examples of such. He also provided several examples of A frame and sandwich board signs in the City right of way or located away from the business's own road frontage. Due to some gray areas in the current code and being in the process of updating the code he asked for feedback on this topic from the Commission. It was the consensus of the Commission to not require a Certificate of Appropriateness for lighted windows signs including open and beer signs. It was also the consensus of the Commission that A

frame and sandwich board signs, which are allowed to be used daily but should be in front each business using such sign and not in various other locations such as, street corners, City landscaping, etc.


Additional Discussion


Adjournment
