A. A Public Hearing for a Request for Rezoning of a 23.854-acre tract of land north of St. Charles Street and west of Crooked Creek, in Cottleville, MO 63304, from Single-Family Residential District (R-1A (1 acre) to Single-Family Residential District (R-1C 1/3 acre), (Lombardo Homes St. Louis, Applicant).

Steve Valentine, with Lombardo Homes, was present for the meeting to discuss this new application featuring 10 home lots offering 3+ car side entry garages and a price point close to \$1.5 million. It was further noted the overall density was 2.4 acres and the applicant has agreed to a binding development agreement locking in the maximum of 10 residential single family home lots.

Mr. Valentine presented photos of the quality water basins they have been building for 15 years in other communities that do not fail. He stated they work with DJM Ecological Services to properly construct the basins as well as planting appropriate plants that have very deep stable root systems. It was noted this application was recommended for approval by the Planning and Zoning Commission.

Alderman Gnau moved to close the public hearing item. Alderman Guccione seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

A. City Attorney

On motion of Alderman Gnau seconded by Alderman Guccione, the Board voted to exit the closed session and return to the open meeting at 6:47 pm. Motion was carried by affirmative votes of four (4) Alderman. There were no nay votes and no abstentions.

B. City Administrator & Public Works Director

During this time, Michael Padella, City Administrator, updated the Board of Aldermen on the agenda items including the new application from Lobmadro Homes for 10 new home lots on the 23.854 acre tract of land north of St. Charels Street and west of Crooked Creek. It was noted the application was approved by the Planning and Zoning Commission and a development agreement is now included for the 10 home lots.

Alderman Guccione moved to suspend the rules for Bill 25-002. Alderman Colombatto seconded the motion. Motion was carried by affirmative votes of three (3) Alderman. There was one nay votes and no abstentions.

Some discussion was held regarding the revised final plan for a coffee truck drive through at Frankie Martins Garden with a right in and right out, no blocking roadway signage and delineators. It was note dt he drive isle could double stack approximately 24 cars.

Alderman Gnau moved to table Bill 25-001 for more information. There was no second. Motion failed.

Alderman Guccione moved to suspend the rules for Bill 25-003. Alderman Colombatto seconded the motion. Motion was carried by affirmative votes of four (4) Alderman. There were no nay votes and no abstentions.

Mr. Padella discussed Bill 25-004, formalizing the recent application to pursue grant funding improving and completing pedestrian safety projects through old town and beyond from Motherhead and Gutermuth all the way to Weiss Road and Cottleville Parkway. More details will be flushed out in the design process if the City is awarded the grant.

Lastly, Mr. Padella mentioned Bills 25-005 and 25-006 restricting parking to one of the street and reducing the speed limit in Cottelville Trails to 20 MPH on various streets within the subdivision.

a. Chief of Police

Dave McCune, Chief of Police stated the PD no longer uses the "work out room' therefore he was remodeling it into office space. He further stated most of the fitness equipment had been donated but it is on tonight's consent agenda to be declared surplus property and sold via bids at a later date.
